Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved the minutes of the February 9, 1981 meeting be approved as recorded. Seconded by Norman Collins.

Commissioner Aurand moved that the payroll in the amount of \$11,839.76 and claims as follow be allowed: Julienne Crowley, cash advanced, postage, legal expense, police supplies, city hall supplies, disposal plant, maintenance material, \$45.18; Hopkins Road Equipment Company, street department, purchase of hazard markers, \$43.81; Hoyle Road Equipment Company, street department, maintenance material, \$62.88; Viking Chemical, disposal plant, chlorine, \$363.00; Yellow Bird Senior Citizen Center, gas bill out of Rev. Mayor Barnes moved to approve the application of J. R. Mc-Inturff, d/b/a/ Just Right Lounge, Inc., for a Class A liquor license, said application having been on file with the city clerk since January 16, 1981. He moved that a liquor license be issued for the Third & Washington Street location, effective March 1, 1981, if the existing license issued to Spiro Glenis is surrendered. Articles of Incorporation, approved February 19, 1981, license and permit bond and a fee of \$100.00, the fee covering the period March 1, 1981 through April 30, 1981 being on file with the city clerk. Seconded by Robert Aurand.

On February 19, 1981 at 12 noon, bids were opened for radio equipment for city vehicles and city hall per published notice in the Republican Reporter newspaper on January 29, 1981. Bids were received from Radio Ranch, Polo and Motorola, Inc., Chicago. Radio Ranch submitted two bids, one for \$5,562.00 and one for \$4,208.00, both bids having exceptions from the specifications. Motorola, Inc. submitted a bid for \$6,359.25, bid to specifications.

Commissioner Ludwig moved to accept bid from Motorola, Inc. in the amount of \$6,359.25 for radios as bid - bids being opened February 19, 1981 at noon. Also, two additional hand-held police radios as per agreement with Bob Snell, representative of Motorola, at \$1,116.50 each. Seconded by Norman Collins.

MAYOR AND COMMISSIONERS REPORTS

Commissioner Ludwig: Advised the council he would like to advertise to sell 25 double headed parking meters in the Illinois Municipal Review magazine. The city has had the meters in storage since they were removed from the Fifth Street Parking Lot several years ago. The council agreed to advertise them for sale.

Commissioner Collins: Advised the council that Rick Canfield of Chana has been billed for the damage to the power pole and wiring at the reservoir, which occurred when he cut a tree down on the Davis property.

Commissioner Svoboda: Advised the council a reply had been received from John Lindhorst in regard to the water draining on the sidewalk by the Yellow Bird Center. He and Mr. Zumdahl will take care of it.

Attorney Smith advised the council that a hearing has been set on the Jasari property on South Sixth St. He will report on the hearing at the next council meeting.

Attorney Smith was instructed by the council to draw up a proposal to submit to the Oregon Park District in regard to the city owned property in the south west area of Oregon. The council discussed the basic conditions which are to be included in the proposal.

Mayor Barnes advised the council that the state liquor hearing for the Tradewinds will be held in Chicago, March 11, 1981. The council agreed that Sheri Reilly and Lawrence Messenger should be subpoenaed to testify.
