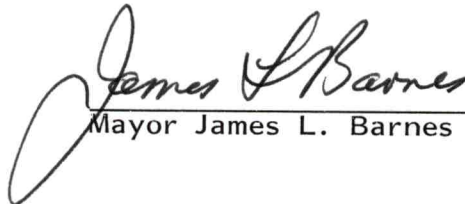
Commissioner Aurand advised that Donna Mann will have the prices for the city picnic to be held in conjunction with the ban concert by the next meeting.
