Mayor Barnes moved to reconvene to regular session. Seconded by Elma Braden.

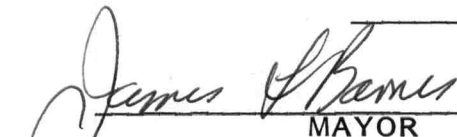
