He advised that the liquor would be removed from the bar, the gas to the beer taps would be shut off and just soft drinks would be available. Mr. Wing advised that the event would be chaperoned by parents and teachers. Willis advised that seven of his staff members would also be there. The parking area will also be patrolled and once the students leave the party, they are not allowed to come back.
