City Clerk Charlene Ruthe thanked Jim Fox from ComEd for the information on the Economic Development meeting in Naperville. ComEd will pay for a four day seminar in Naperville on Economic Development for her to attend. The cost of the seminar is \$525.00 dollars.

Commissioner Thomas Stone informed the council of the meeting with IDOT at the Park District last week. With the intersections being widened this will take away about twenty-five parking spaces in the downtown area. He would like everyone to think about what the city could do to make up these parking spaces. Mike Bowers spoke with Dan Long from IDOT about replacing the sidewalks, curbs, and possibly help with the street lighting. Eighteen street lights will need to be moved with this project. IDOT will be replacing eight of the poles. This would be the time to replace the other ten street lights. Mike is waiting for lighting standers from a company.
