Chief Miller advised he would like to take some action on purchasing a squad car. Mayor Barnes advised that Miller had checked on a price through the State of Illinois Joint Purchasing and the order has to be in by February 28, 1989. The price quoted was \$12,421.88. The specifications were also distributed to local dealers and one bid was received from Bemis Motors in the amount of \$14,420.00.

Resolution
No. 500

Commissioner Logan advised that the Council would either have to waive the bidding process or enact a new resolution to enter into a joint purchasing agreement with the State, as this Council had not done that. Attorney Smith agreed.

Mayor Barnes moved that Resolution No. 500, a resolution to enter into a joint governmental purchasing program with the State of Illinois be passed. Seconded by Norman Collins.

Mayor Barnes moved to accept the bid of \$12,421.88 to purchase a squad car through the State Joint Purchasing Program, with delivery of the car in June, 1989. Seconded by Roger Logan.

The Council set a date to meet with a representative of Department of Commerce & Community Affairs to review the water-sewer rates for March 23rd. Mayor Barnes will notify the representative.

Mayor Barnes asked for the Council's opinion on having a picture taken of our city hall and sending it to the Illinois Municipal League to have displayed in their new office. The Council agreed.

Mayor Barnes advised that the Sesquicentennial Committee has donated a street clock to be set in front of the city hall. When the city hall was remodeled, the base and wiring were installed for a clock to be installed at a later date. The cost of the clock is about \$15,000.00.

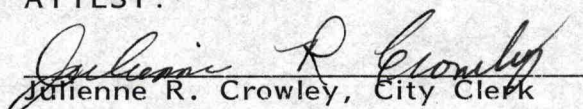
There being no further business, Commissioner Logan moved to adjourn. Seconded by Gail Crenshaw.
