Mayor Mike Arians let the Council know that the police department will not hire an eighth officer this will be a \$40,000.00 dollar saving a year for the City.

Chief Miller reminded citizens that starting March 1, 2000 that the police department will be ticketing people for inoperable vehicles.

Commissioner Amy Trimble attended a grant seminar and brought back information on a CDAP grant for the storm sewer project. Funds up to \$400,000.00 dollars are available for this type of project that is mandated by the EPA. This could also be done in four different phases. This information will be forwarded onto Willett, Hofmann & Assoc.
