Lois Lizer and Chris Merrill, property owners in the proposed annexed area both expressed their objection to the annexation.

enforcement action for noncompliance with Illinois Pollution Control Board Order PCB 78-37, December 4, 1980 in the above-stated matter, as well as for noncompliance with the requirements of the Environmental Protection Act and the regulations contained in Chapter 6: Public Water Supplies. The charges of violations are set forth in Attachment A to this letter.

This matter has been referred to the Agency's legal staff for the preparation of a formal enforcement case. The Agency intends to refer this matter to the Office of the Attorney General for the filing of a formal complaint for injunctive relief and a penalty for noncompliance.

Pursuant to P.A. 82-269, effective January 1, 1982 which amends Section 31 (d) to the Environmental Protection Act, the Agency will provide an opportunity for Village officers to meet with the appropriate Agency personnel in an effort to resolve such conflicts which could otherwise lead to the filing of a formal complaint. This meeting, if it is to be held, is required to occur within 30 days of your receipt of this notice unless a postponement is agreeable to all parties.

Mayor Barnes was to notify Attorney Krahenbuhl February 9, 1982.

ADDITION TO MINUTES OF FEBRUARY 8, 1982

The Clerk advised the Council she had received a call from Rockford Electric Power Contractors in regard to a bill for a call to Veterans Field in May, 1981 which has not been paid. At that time, the contractor was called because some of the lights were not working and being within a year of installation the repair would have been under warranty. When the contractors arrived with their equipment, the lights were working properly so they felt the call was not a warranty call therefore they had charged the city \$208.04 for the call.
