- 1. Advised that if the City is going to apply for a grant this grant fiscal year, preliminary work should be started now. Commonwealth Edison will meet with the City Council Thursday, March 11, 1987 to discuss street lighting.
- 2. Advised that before the State starts construction on Route #64, the scale should be removed on Washington Street. The sidewalk can be done later.

Chief Miller gave the February police activity report and advised that Gary Heimstead had donated a blackboard which was put on the wall in the Community Room.

Attorney Smith presented the agreement drawn up between the Oregon Bible College and City of Oregon for stairs to be constructed on city right-of-way on Franklin Street at the corner of Franklin and Seventh Street. The City agrees to make a contribution of \$1,000.00 toward the construction of the stairs. The college shall file its certificate of insurance showing liability coverage in an amount no less than one million dollars. The college shall accept ownership of the stairs and shall be responsible for all costs to maintain, repair and rebuild the stairs.
