We can only have two signs put up so the city needs to decide which areas they would like them placed. Mike suggested on Route 64 coming from the east and north on Route 2. Mike asked if the council would think about this and let him know so he can forward this on to IDOT.

Commissioner Bob Rees suggested to the council that the city charge a deposit for the keys that are taken out for the coliseum when renting the building. People are using the building and not bringing the keys back.

Mayor Mike Arians announced that the Intouch Program along with the police department will be having a program Monday March 24, 2003 at the coliseum for the liquor license holders and their employees.
