Police Training Request Gary Heimstead, Auxiliary Police Officer, addressed the Council requesting permission to attend a Police Tactical Firearms Course in June. He advised that since the State will not reimburse half of the cost for auxiliary officers, he is asking that the City pay the one half and he would pay the other. The City Clerk advised the Council that she would like for them to be aware of the costs that Gary has saved the City just from the first of the fiscal year by donating his time and expertise to install the radio and light equipment in the squad cars. Also that he has donated his time to assist Sgt. Hitchcock with the in-house training for the police department. On the radio and light installation alone, a minimum of \$1,100.00 has been saved. Taking this into consideration, she recommended that the City pay the entire costs for Heimstead to attend the training course. Also that each request for auxiliary training be considered on an individual basis, rather than an overall policy.

Commissioners Norman Collins, Frank Svoboda and James Ludwig agreed that the City should pay the entire costs.

Mayor Barnes and Commissioner Braden abstained from the discussion.

Recommendations for Projects:

- Street Maintenance recommendation for this year: Fifth and Sixth Streets north of Monroe and a portion of Tenth Street. Cost: Estimate \$25,000.00 from Motor Fuel Tax.
- Water-Sewer: Fifth Street Mix Street (this year)
- To connect East Oregon water to west side depending on where connected, could be \$15,000 or \$50-60,000. (this year)
- Reconstruction Projects Oregon Trail Road, Mix, Jackson, Jefferson and Third Streets.
- 5. Advised that to redo Franklin Street, the Oregon Bible College will have to remove the steps down to the street.

 The Clerk will advise them. Also the engineer is to be contacted for the proper location when they are ready to remove the steps.
- 6. Advised he has been in contact with Bob Glaser, Village of Progress, and they are still having problems with the water pressure and their sprinkler system. He will investigate further.

Mayor Barnes advised that at the police meeting, the holiday schedule was discussed and the police are requesting that they can take the holidays in advance, therefore eliminating more than one being off duty at one time and cutting down the time and expense of using the auxiliary police. The Council agreed that this could be tried for the balance of this year and if successful, could continue.
