Commissioner Priller advised that a schedule has been made for lawn waste and brush pick up for the season.

Attorney Smith suggested the Council hold a public hearing to explain to the residents about the East Oregon Water Project.

Phyllis Garard addressed the Council with complaints about the gas company tearing up the terrace and about Larry Wilson and his building on Worth Street.
