Engineer's Report

1. State will begin Route #64 construction next week.

Bill Kaufman, owner of Oregon Super Valu, and Earl Gambrel, owner of that property, addressed the Council seeking assistance and cooperation in resolving the problem with public use of the private parking lot at Fourth & Franklin. Because of the increase in use of the Coliseum, people park in the private lot, causing a loss of business for the store. The Council agreed to post a sign in the Coliseum asking people not to use the lot and advising people when they rent the Coliseum that it is unlawful to use the lot. Also, Kaufman was given approval to ask off duty police officers to patrol the lot during the time of big events being held at the Coliseum. He will be furnished a list of upcoming events from City Hall.

Citizen Request

Commissioner Braden advised that Spring Clean Up Week will be May 4th thru May 8th, 1987. A notice will be put in the paper for five weeks.

Clean Up Week

Attorney Smith advised that Carnation had requested that the secondary agreement on the disposal plant be terminated. Smith advised that it would be to the City's advantage to keep the agreement as is. It would not cost Carnation anything and it might be beneficial to a new buyer of the plant. The Council agreed.

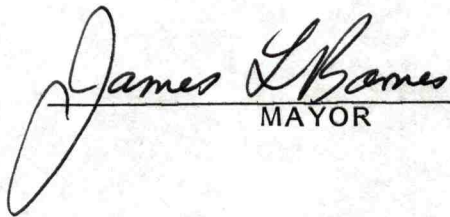
There being no further business, Commissioner Collins moved that the meeting be adjourned.

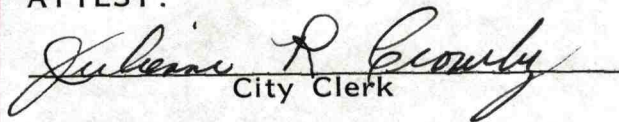
