COUNCIL MEETING March 27, 1995

Request to Annex Prop. Phil Weimer, representative of Century 21 Country North, requested an extension for the Ballard Land Development at the west edge of Oregon off of Oregon Trail Road as outlined in a November 2, 1994 letter. The Council agreed to extend the time until the end of the year.

Commissioner Svoboda advised that letters are being sent to residents on Eighth Street to hook onto the new water and sewer lines before the street project begins. There are ten other residents who need to hook on but it will not interfere with the street project. The Council agreed to set the time limit for the ten residents to six months.

Chief Miller advised all in attendance of the Gang Awareness Seminar to be held April 2, 1995 at the Coliseum.

Commissioner Priller advised that the Street Department is in need of a replacement truck because it is almost impossible to get parts to fix the old one.

Commissioner Priller moved to purchase a truck through the Joint State Purchasing for the amount of \$45,385.00 and a plow from Hoyle Equipment for \$4,115.13. Seconded by Robert Aurand.

Commissioner Aurand referred to a letter from Thom Palmer of Oregon Park District in regard to summer concerts in the park. He advised he would like to use City band funds to sponsor the July 25th concert in the amount of \$1,200.00. He advised the concerts will be held at Oregon Park West. The Council agreed with Commissioner Aurand's recommendation to sponsor the July 25th concert.

Commissioner Aurand advised he had received a request from Arts Alliance for City band funds for a music group to perform at Pinehill during Autumn on Parade. Aurand advised he is against the City participating financially for any event held on private property or outside of the City property. The Council agreed.

Mayor Barnes advised he had put together a list of priorities for the Blackhawk Hills Economic Development request and asked for any additions or changes. Commissioner Svoboda asked that the storm water retention pond be included and the Council agreed that a city building code and updating the Comprehensive Plan should be included.

Jim Grove, Oregon Park District, requested another water meter be put in at Fairgrounds Park that they could use to water the lawn without having to pay District the sewer charge and they would also like to let the cemetery use the water. The Council advised that they couldn't waive the sewer fee for watering but if the Park District wanted to put in another meter, they could and if they wanted to give water to the cemetery, that was up to them. The Park District would be paying for the water.

Oregon Park Request

Jim Grove advised the Park District is going to have a committee to study a proposal of putting part of Lake Mistake into a natural area. He advised he would be happy to have a representative from the City be on the committee.

There being no further business, Commissioner Aurand moved that the meeting be adjourned. Seconded by Gerald Medlar.
