Commissioner Logan moved that the City Council hold a public hearing on April 25, 1988 at 7:15 P.M., Council Chambers, in regard to amendments to the zoning ordinances permitting bed and breakfast establishments as a permitted use in R-1 areas. Seconded by Gail Crenshaw.

Commissioner Logan explained that by the Council holding the public hearing instead of the Plan Commission it would expedite the procedure about one month. He asked that the attorney prepare the ordinance.

Mayor Barnes moved that the City of Oregon and Youth Service Bureau of Ogle County enter into an agreement allowing the City Council to appropriate a Youth Service Bureau line item in their annual appropriation ordinance in exchange for services provided by the Youth Service Bureau as listed in the Agreement Document. The Agreement shall run from its effective passage until April 30, 1991. Seconded by Roger Logan.

Mike Maxson, representing the Chamber of Commerce, addressed the Council asking that a tax abatement resolution be enacted for new or existing industrial expansions. The Council will take this under advisement.

Commissioner Logan advised he had received an updated proposal from Business Records Corporation and would talk to Chief Miller about it.

Commissioner Logan advised that he had tentative plans for two summer concerts and is negotiating on the others.

Commissioner Lauer asked that the Council review the statutes on bypassing bid requirements for sidewalk work that he would like to proceed with this summer.

Commissioner Lauer advised that the bid letting for street maintenance would be sometime in April.

Mr. and Mrs. Richard Spialek of 105 Jones Terrace addressed the Council in regard to the property north of theirs. They advised that there is an ongoing flea market and junk and debris all over the property. The people disassemble T.V.'s, etc. and the freon sprays all over. The Council instructed Attorney Smith to draft a letter to LaPointes and advise that this is in violation of the city code.

Dan Reimer of 905 South Third Street addressed the Council and asked if residents benefiting from the alley behind their property would share in the expense, if the City would consider seal coating the alley. The area is 362 feet long and 10 feet wide. Commissioner Lauer advised he would get an estimated cost and advise Reimer.
