Commissioner Aurand announced that the City will be sponsoring the Crystal Lake Community Band in the summer concert series at Oregon Park District for the cost of \$500.00.

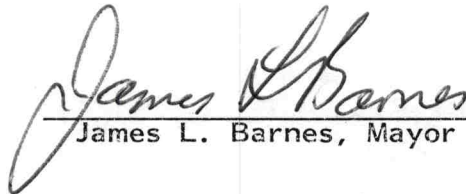
Mayor Barnes advised the Council that the letter from Vince Celest in regard to the mobile home park will be referred to the Planning Commission.
