The Council of the City of Oregon met in regular session Monday, April 12, 1982, 7:00 P.M., City Hall Building.

Present: James Barnes, Mayor and Commissioners Robert Aurand, Frank Svoboda, James Ludwig and Norman Collins. Absent: None.

Also present: City Attorney David Smith and City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved that the minutes of the March 22, 1982 meeting be approved as recorded. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Aurand moved that the payroll in the amount of \$10,764.91 and claims in the amount of \$20,138.68 previously recorded, be approved. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Ludwig moved that Resolution #414 requesting the closing of State Highways 2 and 64 for the purpose of using the highways during Autumn on Parade be passed. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Aurand moved that the firm of Lindgren, Callihan, Weaver and Van Osdol, Certified Public Accounts, be retained to audit the City's accounts for the year ending April 30, 1982. He further moved that the firm be paid the sum of \$2,900.00 for performance and upon completion of the audit. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Mayor Barnes moved that a "Proposed Use Hearing" covering Entitlement #13 Federal Revenue Sharing funds be scheduled for: May 10, 1982 at 7:05 P.M. at the Council Chambers, City Hall Building; that the hearing be open to the general public for oral and written comments on possible use and requests for funds. He further moved that the City Clerk be directed to publish notice of proposed use hearing in the Republican Reporter newspaper on Thursday, April 15, 1982. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Mayor Barnes moved that Craig Danekas be hired as a regular full time police officer for the City of Oregon, effective May 1, 1982. He recommended his starting salary be set at \$14,000.00 annually, with a performance and salary review in 60 days. He further moved that as of August 1, 1983, his annual salary shall be adjusted to the going rate paid full time patrolmen. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Collins moved to adjourn to executive session to discuss the sale of the North Third Street Well #1 property. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Collins moved to reconvene to regular session. Seconded by Frank Svoboda.

Commissioner Collins moved that the bids submitted by William Schensky and Morrie Cann for the purchase of the North Third Street Well #1 property be rejected. Seconded by Frank Svoboda.

A public bid opening was held at 1:00 P.M. Monday, April 12, 1982 for the sale of the North Third Street Well #1 property. Two bids were submitted: William Schensky of Sycamore in the amount of \$8,351.00 and Morrie Cann in the amount of \$7,000.00. Both bids were rejected. The bid security checks were returned to Cann and Schensky at the meeting.

Farrell Brewer, a resident in Wright Subdivision, addressed the Council with complaints on the streets in the subdivision. He stated the streets were breaking up and were only about a year old. He requested the Council to check to see if the streets were built according to city specifications. Willett and Hoffman engineers submitted a certification on the completion of the streets.

The Council discussed the street in Williams Subdivision #2, which is annexed into the City. According to the minutes of the Plan Commission in 1974, the subdivision improvements were to be made within five years. To date, the street is not completed. The Clerk was instructed to contact Williams to attend the next council meeting.

Commissioner Aurand advised the Council that Kim Davis has agreed to take the summer band program. As soon as the details are arranged, a motion will be submitted for Council approval.

There being no further business, Commissioner Aurand moved that the meeting be adjourned. Seconded by James Ludwig.
