Another complaint is the dog Traver has which bit one of Bond's tenants who live next door. The dog was on Bond's property at that time. The Council advised that they are trying to do something about the junk and will check on the dog, which was to have been put to sleep.

Bond advised that he has a problem at his property at 308 South Fourth with the sewer backing up. He requests that the City keep the line clean to eliminate the problem.

Bond advised that there is a water problem in the Fifth St. parking lot. When the lot was built, it was made higher than the buildings, causing water problems behind the buildings. The Council will look into the problem.

Grant Landis addressed the Council in regard to communication between the City and developer at Fairgrounds Estates. Mayor Barnes advised that there will be a meeting on Tuesday morning. Landis would like to meet maybe once a week to see that the project is going smoothly.

Commissioner Medlar advised that he had checked on the Hazaroud Waste collection day April 24, 1993 in Dixon and was advised that they want each individual to take their own waste to the site.

Chief Miller advised he would like to have an auction date set. Judy Crowley will work with Mike Bowers to get one set up.
