Commissioner Priller advised he had met with representatives of Conover Square and they would not like to have parking meters in front of Conover but would like to have two hour parking signs put up and they would help to enforce the time limit. The rest of the meters on Third Street and Franklin will be put in.

Mayor Barnes advised that he would like to meet with the Park District and School Board in regard to extending Jefferson Street. He and Commissioner Priller will meet with the other boards.

Mayor Barnes advised that he had talked to Jim Grove in regard to a museum tax and would be attending a park district board meeting to discuss the possibility of entering an intergovernmental agreement to levy for a museum tax.

There being no further business, Commissioner Aurand moved that the meeting be adjourned.
