The Council approved Chief Miller's request to have the 1993 Caprice squad car rebuild by Stan's Performance for \$3700.00.

Chief Miller advised the Council he has asked Dr. Banicki to consider having closed campus again over the lunch periods because of the traffic and accidents.

Commissioner Aurand advised that the Project Portage is in its third year and it is for youths at risk. The total cost is \$1900.00 and they send seven kids to it. That is the \$100.00 warrant to the Oregon Park District for a share of the project.

Commissioner Aurand advised he has been negotiating with EMC on their contract and has met with Jeff Mummert and Tim Hasara. He advised that before each meeting with them he has told them this was his viewpoint and not the entire council and when the agreement is reached, it would be sent to Attorney Smith to check and to have EMC officials sign it first. The Council agreed to this procedure.

Commissioner Aurand advised that the Recreation Board has met on the pool and it will cost about \$5000.00 plus supplies to get started. The major work will be the piping. An ad will be put in the paper for guards.

Commissioner Aurand explained the Early Retirement Incentive plan offered by IMRF to the Council. There are five employees eligible to take this plan. There is a one year window if the plan is adopted in which the employee has to retire but they hav e to file their notice of intent within two months prior or two months after the effective date as passed by the council. The plan cannot be offered again until the city's share is paid off. The Council will ask for a letter of resignation stating the time of resignation from the employee.

Mayor Barnes advised the council of an emergency situation on the Rt. 2 project. Martin & Co. and Rockford Blacktop have submitted bids for storm drains going into the new state storm system on Hill Street. The locations are 4th and Clay and 4th and Madison Streets. Rockford Blacktop bid is \$74,506.36. Martin & Co. bid is \$64,581.20.

Commissioner Myers moved to proceed with Martin & Co.bid of \$64,581.20 as an emergency situation, contingent on the engineers approval and the approval to use Motor Fuel Tax funds for the project, seconded by Gerald Medlar
