The city parcel is 90 feet of Tenth Street south of Route #64 by 66 feet and tax exempt for easements. The Council feels that this should go to the next Council. The City will check to see if there are any utilities on that parcel before the next meeting.

Ray Hawk was in attendance and extended an invitation to everyone to stop by and see what the Boxing Club was doing for local children.

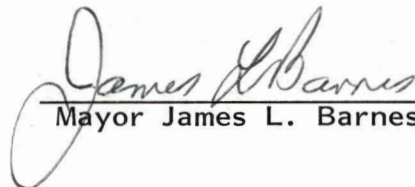
Mayor Barnes advised that the Park District had rejected the pool operation for this summer.
