Mayor Barnes presented Warren and Nancy Miller with a plaque.

Commissioner Crenshaw advised that she had been in contact with Sue Whitman of Responsible Peer Program and a meeting has been set up with the Student Government Committee to visit the Mill in Rockford on June 14th at 10:00 A.M. and an invitation was extended to anyone interested in touring their facility.

Attorney Smith advised he had received a letter from the Vice Chairman of Responsible Peer Program. They had contacted Smith about a week ago inquiring what the City's position was. He responded to them that the City's position was in the code book. They could determine for themselves what they had to do and they should take whatever steps they thought necessary. Vice Chairman Prorok stated in his last letter that they interpret the code that their intended use of the Bible College property is a permitted use under R-1 Zoning and they don't feel that they have to come to the City for any approvals. After discussion, Mayor Barnes asked how many were in favor of holding a public hearing in this matter. Mayor Barnes was the only one for a public hearing.

Commissioner Collins moved to direct Attorney Smith to contact Responsible Peer Program and ask for documentation that they are a school. Seconded by Gail Crenshaw.
