April 26, 1982 Oregon, Illinois

The Council of the City of Oregon met in regular session Monday, April 26, 1982 at 7:00 P.M., City Hall Building.

Present: James Barnes, Mayor and Commissioners Robert Aurand and James Ludwig. Absent: Commissioners Norman Collins and Frank Svoboda.

Also present: City Attorney David Smith, Chief of Police Robert Jones and City Clerk Julienne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved that the minutes of the April 12, 1982 meeting be approved as recorded. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays.

Commissioner Ludwig moved that the minutes of the executive session held April 12, 1982 be approved as recorded. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays.

Commissioner Aurand moved that the payroll in the amount of \$10,996.42 and claims in the amount of \$33,258.61 previously recorded be approved. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays.

A public hearing was held on Ordinance #862, filed and introduced on March 22nd, notice of such hearing published in the Republican Reporter newspaper on March 25, 1982, an ordinance to vacate a portion of the northeast corner of the right-a-way of Third Street and Illinois Street for the purpose of selling that property together with other city property located adjacent to and northerly and easterly of said property.

Wendell Long, an Oregon resident, addressed the Council expressing his opposition to vacating the property because there is a sewer line which runs through it. Also many area residents use the property for fishing and outings.

Mayor Barnes suggested the proposed ordinance be tabled at this time because of the absence of two council members and also to allow time for the council to review it further.

Commissioner Aurand explained that a resolution must be passed before the end of the fiscal year to make interdepartmental transfers from one line item to another within a department when the appropriated amount was not sufficient throughout the year. Commissioner Aurand read the resolution then advised the council that a 2/3 vote from the governing body was necessary to act on it. The Council tabled this motion until a later date.

Commissioner Aurand moved that the City Treasurer be instructed to transfer funds as follows: From Sales Tax to: Public Affairs, Salaries, \$15,000.00; Public Affairs, \$9,000.00; Police, \$9,000.00; Police Protection, \$25,000.00; Street Lighting, \$8,000.00; School Crossing Guard, \$700.00; Group Insurance, \$10,000.00; Working Cash Fund, \$1,500.00; Public Health, \$2,000.00; Street & Alley, \$40,000.00; Parking Meter, \$2,000.00; Coliseum, \$500.00. Seconded by James Ludwig.

April 26, 1982 Meeting Continued Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays. A Bill of Sale signed by residents on Webster Street was submitted to the Council, requesting that a 6 inch sewer line which is tied into the city sewer on the northwest corner of Sixth Street and extends west on the north side of Webster Street approximately 170 feet, be transferred to the City of Oregon. Mayor Barnes moved that Resolution #415, a resolution to accept a 6 inch sanitary sewer line, be passed. Seconded by James Ludwig. Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays. Mayor Barnes proclaimed the week May 2-8, 1982 as Physical Fitness and Sports Week; May 9-15,1982 National Nursing Home Week and May 9-15, 1982 Municipal Clerk's Week. Mayor Barnes explained to the Council that Craig Danekas, who was hired by Council action on April 12, 1982, notified him that he decided to stay with his present position with the State of Illinois and declined the job offer. Therefore, Mayor Barnes moved that Jeff Whitsell be hired as a regular full time police officer for the City of Oregon, effective May 15, 1982. He recommended that his starting salary be set at \$14,000.00 annually, with a performance and salary review in 60 days. He further moved that as of August 1, 1983, his annual salary shall be adjusted to the going rate paid full time patrolmen. Seconded by Robert Aurand. Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays. Mayor Barnes moved that the application of John Willson, D/B/A Stenhouse, for a Class A Liquor License be approved, that the surety bond be approved - all for the period May 1, 1982 through April 30, 1983. He further moved that the payment of \$300.00 for the six month period May 1, 1982 to October 31, 1982 be approved. Seconded by Robert Aurand. Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays. Mayor Barnes moved that the application of Richard C. Jones, D/B/A Dick's Pub, for a Class A Liquor License be approved, that the surety bond be approved - all for the period May 1, 1982 through April 30, 1983. Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays. Mayor Barnes advised the Council that in regard to the application of the Tradewinds they were in violation with a city code, Title 5, Chapter 4, Section 25, "View From the Street".
Mayor Barnes presented the Council with pictures of the front of the establishment, showing that curtains are drawn over the front windows and therefore, the interior of the establishment is not visible. The Council instructed the Clerk to write Tom Tomaras, registered agent for C. L. Oregon, Inc., D/B/A Tradewinds, advising him that a license would not be issued until this violation

was corrected. Mayor Barnes then moved that the application for C. L. Commissioner Aurand advised the Council that a suggestion had been made to have the summer band concerts held at the Nash School instead of on the courthouse lawn. The Council was in favor of this change. Commissioner Aurand will contact the Superintendent of Schools and Park District to request permission to have the concerts held at Nash School.

Gene Hardick, representative of R. C. & D., requested a letter be submitted to the Soil Conservation Service if the City did not wish to participate in the flood proofing with dikes in the southwest area of the city. The Clerk was instructed to submit a letter stating that the city did not wish to participate in this project.

Commissioner Aurand moved to adjourn until 6:00 P.M., Tuesday, April 27, 1982. Seconded by James Ludwig. Said motion carried on roll call as follows: Ayes: Aurand, Ludwig, Barnes. No nays.
