An Organizational Meeting was held Wednesday, April 27, 1983, at 7:00 P.M., City Hall Building.

Present: James Barnes, Mayor and Commissioners Norman Collins, Elma Braden, James Ludwig, Frank Svoboda. Absent: None.

Also present: City Attorney David Smith, City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

The Honorable Judge F. Lawrence Lenz conducted the inauguration of the Oregon City Council.

Mayor Barnes moved that on a permanent basis, that: Commissioner Norman Collins shall be Commissioner of Accounts & Finance; Commissioner Elma Braden be Commissioner of Public Health and Safety; Commissioner James Ludwig be Commissioner of Streets and Public Improvements; Commissioner Frank Svoboda shall be Commissioner of Public Property; Mayor James Barnes shall be Commissioner of Public Affairs. All appointments to be for a four year period beginning May 1, 1983 to April 30, 1987, or until their successors have been appointed and qualified. All appointments subject to the provisions of the City of Oregon Code and the Illinois Revised Statutes. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Mayor Barnes confirmed that Robert Jones be named Acting Chief of Police; Thomas Miller be named Police Sergeant; William Hitchcock, Edward Bowers and Jeffrey Whitsell be named as full time patrolmen for the police department. Terms to be May 1, 1983 - April 30, 1987. All appointments subject to the provisions of the City of Oregon Code and the Illinois Revised Statutes. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Mayor Barnes confirmed that David Smith be re-appointed City Attorney for the City of Oregon - term effective May 1, 1983 - April 30, 1987, salary set at \$2,000.00 per annum. Seconded by James Ludwig.

He approved the City's Treasurer's Bond in the amount of \$15,000.00. The appointment is made in accordance with the City of Oregon Code and Illinois Revised Statutes. Seconded by Norman Collins.

Said appointments to be effective May 1, 1983 - April 30, 1987 and shall be in accordance with the City of Oregon Code and the Illinois Revised Statutes. Seconded by James Ludwig.

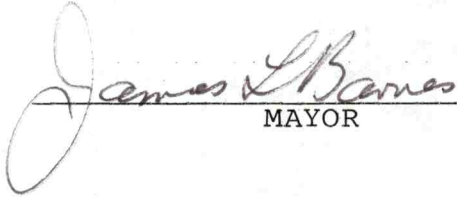
Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

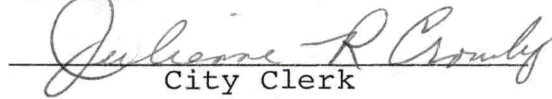
There being no further business, Commissioner Ludwig moved that the meeting be adjourned. Seconded by Norman Collins.
