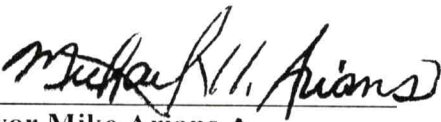

Commissioner Gerald Medlar moved to adjourn, Seconded by Commissioner Amy Trimble.

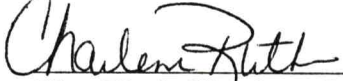
