This authorization is pursuant to Chapter 24, Sec. 8-1-7, Illinois Revised Statutes. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Wayne Reising of Deuth and Reising, Inc., gave a presentation on group medical and dental insurance to the council. The council advised Reising that the proposal would be discussed and he would be advised on Tuesday of the council's decision whether or not the city will change to their insurance company.

Pineway Food and Liquor, Inc. requests that it be allowed to sell alcoholic liquor on Sundays between 12:00 noon and 10:00 Presently, Ogle County allows sales during these hours at locations very close to the Oregon City limits. Krahenbuhl KDK:sak cc: Mayor James Barnes Krahenbuhl and Dan Dunlap both spoke to the council. The council reviewed the request and instructed the clerk to publish a public notice to hold a hearing May 23, 1983 at 7:00 P.M., City Hall Building, for citizen comments on Sunday liquor sales. The council discussed the application of Mitch and Melba White Hydropower that was published in the Republican Reporter paper to build a hydropower plant at the Oregon Dam. It was decided that the city should respond in protest of the permit filed by them. Dean Dye addressed the council with his concern and advised that he was going to file an application to construct a power plant on a smaller scale since this would directly affect Conover Square and he does own a small portion of the dam. Attorney Smith was instructed to respond to this notice. Dennis McMullen, engineer, gave a report on various city projects. Mayor Barnes discussed the deterioration of 14th Street in Wright Subdivision. The council agreed that Wright be contacted and instructed to correct the problem - in accordance with the subdivision code. The following letter was submitted to the council from the Oregon Park District:

in having Industrial Revenue Bonds issued to finance the project. The council agreed that they would be willing to issue the bonds and would cooperate in any way to bring industry to Oregon.
