Bernie Trowbridge, representative of the Oregon Bowl, requested permission from the Council to hold teen nights at the Oregon Bowl through the summer on Friday and Saturday nights from 6:00 P.M. – 11:30 P.M. All the liquor would be removed from the bar area and they would have teen bands, volley-ball and other teen activities. They would like to have a "kick-off" night on June 8th which would be free to the graduates and start the teen night on June 10th and run every weekend through August 13th. This would be for teens between 13-19 years of age. Attorney Smith advised the code would have to be amended to provide for this. He will have the amendment ready for the next meeting. The Council thought this would be a good idea for the youth.

Bernie Klingenberg, engineer with Willett, Hofmann & Associates, explained the proposed water-sewer rate increase ordinance. Commissioner Svoboda moved to introduce and file for public inspection Ordinance #1051, Water-Sewer rate increase ordinance.
