Mayor Barnes explained the dewatering system at the Fairgrounds project.

Reports

Commissioner Aurand questioned Willett, Hoffmann's recommendation to waive the bid security irregularity of R. E. Wolber & Sons' bid for the retention pond project. The bid security was to have been 5% and Wolber submitted 3%. Aurand also questioned Martin's bid that stated it could be reduced by \$330.00 if the City waives the Performance Bond requirement. The Council did not act on awarding the contract on that project.

Commissioner Aurand advised that the Recreation Board is taking applications for life guards for the pool.

Mayor Barnes advised that Attorney Smith had contacted three different people in regard to property for the East Oregon well and water tower. He advised that it would be approximately 4000 feet from the tower location to where it would be tied into the main at Mix and Daysville Road. The engineer said the tank should also be approximately the same size as the tank on the west edge of town. The engineer said that if the City does that, they can go to a night pumping rate which will be a lot less expensive.

Mayor Barnes advised that he had received a letter from Atwood, who plans to up their employment this fall and has asked if the City could help with their water line. The line at the road is large enough but they need to run it into the plant. He will keep the Council posted on this.

Mayor Barnes advised that the Police Department will have a display at Cherry Vale Mall this weekend for National Police Week.

Phyllis Garard asked if anything had happened with Larry Wilson this week for his property on Worth Street. Mayor Barnes advised that Wilson has filed his engineer's report with the City's engineer. The engineer will get back to Wilson.

There being no further business, Commissioner Aurand moved that the meeting be adjourned.
