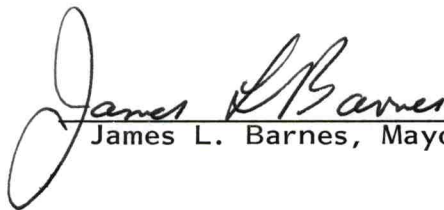
Mayor Barnes proclaimed May 15th and 16th VFW Buddy Poppy Days and this week as National Law Enforcement Week.
