Casey Duffey, representative of Countryside Village, addressed the Council with a concern over the alley to the south side of their property. They have heard some talk of vacating the alley which would affect the access to their property. The Mayor advised that all property owners have to agree to vacate so if they don't agree, it cannot be vacated.

Andy Robinson addressed the Council in regard to Sandsucker Recreation Area and asked for direction in developing the area. Mayor Barnes advised that there has been considerable damage to the facility over a period of time. Mayor Barnes advised that the Council will look over the park and give Robinson an answer at a later date.

Joyce Long, of White Pines Realty, addressed the Council in regard to the Ross property at Tenth & Washington Streets. The Council advised Long to ask Ross to give the City an offer for the city property at that location.

Jack Swanson, Luthern Ministries, asked the Council if the City could participate with the cost of removing debris from Gale Creek which the City has easements on. The cost was \$175.00. The Council will take this matter under advisement and let them know their decision.

Mayor Barnes proclaimed May 18th V.F.W. Poppy Day.

Commissioner Aurand suggested that all employees should be confirmed, not just the clerk's office and police department. This will be done at the next meeting.

Commissioner Aurand advised that Harry Early has been hired by the Recreation Board to take care of the swim pool this year. The necessary repairs are being made.

Mayor Barnes advised that he would like something done about the inoperable cars around town. The Council decided to let citizens know that the Council is going to clamp down on inoperable vehicles starting June 1st.

The Council discussed the resignation letter received from McClure Engineering. Commissioner Aurand feels that McClure Engineering should be invited down to discuss the invoicing and records with the Council before a settlement is made.

Commissioner Aurand moved that the City Attorney be directed to send McClure Engineering the termination notice as provided on Page 9 of the Administrative Engineering Agreement dated 12/29/87. Seconded by John Priller.

The Council authorized Commissioner Svoboda to talk to Willet, Hofmann Associates about engineering on the Disposal Plant Improvements Project already underway and to bring a proposal to the next meeting.

The Council discussed the street department picking up the lawn waste and taking it to the dumpster at the street garage. Commissioner Medlar is going to talk to Moring Disposal about this.

Mayor Barnes asked the Council if Attorney Smith could be directed to draw up an ordinance putting the Mayor back on the Planning Commission as an ex-officio member and put the Commissioner of Health & Safety back on as a voting member.

The Council agreed and Attorney Smith will have the ordinance ready at the next meeting.

Mayor Barnes advised that two things that need immediate attention this summer is a new roof for City Hall and the reservoir needs to be cleaned and painted. Commissioner Svoboda advised that someone will be here next week to give an estimate on the reservoir.
