Mayor Barnes announced that he had received a fax from the Illinois Municipal League stating that the legislature is looking very strongly at not honoring a commitment to change the income tax surtax from 1/11th per capita to 1/10th. The legislature may keep the surtax at 1/11th or even 1/12th.

He then moved that Resolution #565 - Urging the Illinois State Senate, House of Representatives, and Governor to Not Change the State Income Tax's Local Government Distributive Fund Distribution Formula. Seconded by Jerry Medlar.

Chief Miller presented the April, 1995 police activity report. It was noted that there have been 30 felony arrests through April as compared to 19 for all of 1994.

Reports

Commissioner Suneson announced he had looked over the petitions requesting street repairs on South First Street. Commissioner Suneson and Street Superintendent Bowers will meet to try to alleviate the problem.

Mayor Barnes acknowledged a petition asking for stop signs at the intersection of Depot and Scott Streets. Commissioner Suneson and St. Superintendent Bowers will check the situation.

Commissioner Aurand explained a packet received from the Oregon Park District about Project Portage. The City has paid \$100.00 for this project to help pay the cost of a two week session for six individuals - 11 to 13 years of age - who are having behavioral problems. The goal is to give these individuals some self confidence, a change of environment and a better outlook on life.

Mayor Barnes announced that the documentary filmed in Oregon will air on TBS May 30, 31 and June 1, 1995.

Mayor Barnes announced receipt of a plaque from the Fifth Grade DARE graduates and Officer Gary Schultz expressing their gratitude to the Mayor and City Council for its support of the DARE program.

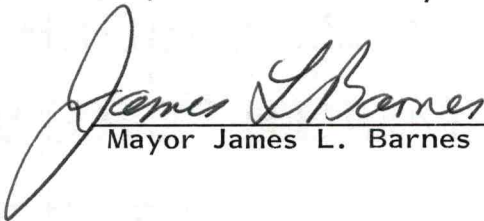
Commissioner Myers suggested a letter of appreciation be sent to Woods. He & the Mayor will work on this.
