Commissioner Medlar advised that he and Mayor Barnes have met with Larry Moring to discuss apartments participating in recycling. The City will be contacting apartment residents and Larry Moring will contact businesses in regard to the program. The City will provide Moring Disposal with a list of apartment buildings. Commissioner Medlar also advised the City will clamp down on recycling non-participants.

Reports

Commissioner Svoboda advised that the lift station is still not in.

Chief Miller advised he feels it is time to contact the Oregon Park District for help in policing the parks. The Park District had earlier expressed interest. Commissioner Aurand would prefer that all of the park property be within the city limits. The Council agreed that Chief Miller should proceed.

Chief Miller also advised that Sergeant Hitchcock has returned to work.

Commissioner Aurand advised that brochures had been received from the Discovery Group of Madison, Wisconsin in regard to a comprehensive plan. The brochures feature Lodi, Wisconsin at a cost of \$26,000.00.

Commissioner Aurand also advised that by June 1st the City should receive \$700,000.00 as a result of the Working Cash Bond Ordinance. This and the interest accrued will be kept in a separate fund for capital improvements. He has asked the Clerk to check interest rates.

Mayor Barnes advised that in regard to property for the East Oregon well and water reservoir, he and the city attorney and Engineer Klingenberg had met with a property owner who may be interested in participating with the City. He advised that an 850,000 gallon reservoir and a well would cost about \$1,000,000.00. The maximum amount of a grant would be \$400,000.00.

Mayor Barnes advised that the Fairgrounds drainage system should be finished in two days and the city workers have done a terrific job.

Mayor Barnes announced that the police exhibit at Cherryvale Mall was well done and the squad car placed second.

Mayor Barnes advised that BOCA building code book are available for the Council to look over.

Phyllis Garard requested a copy of Mr. Wilson's engineering plan.
