Hank Johnson and Ed Rader, representatives of Farm Service, addressed the council requesting consideration be given Farm Service for the city's petroleum products purchases.

Earl Gambrel, owner of the Super Valu parking lot property, addressed the council to explain why the "Customer Parking Only" signs were put up in the parking lot. At the time of the original agreement for the city to financially participate partially in the installation of sidewalks and curbs at that location, it was agreed that the lot could be used for parking for coliseum events. Gambrel explained that there was so much loitering and littering in the lot after store hours that the police advised them that the only way they could control the problem was to install the signs.

Dennis McMullen, representative of McClure Engineering, gave a report to the council on the well and water main project.

The council agreed to delay the city hall parking lot project for this year.

The council discussed the following letter received from Rock Valley Disposal Service:
