Commissioner Priller moved to appoint Mike Bowers as Supt. of Streets; Wayne Suter, Glenn Bennett and Bill Thompson, street department employees. He further moved that Bill Thompson be appointed part time animal control officer.

Commissioner Svoboda moved to appoint Roger Warrenfeltz as Supt. of Water-Sewer and Wastewater Treatment Department; Harry Fletcher as Asst. Superintendent; Dave Kitzmiller, employee of the Water-Sewer and Wastewater Treatment Department. He further moved to appoint Harland and Velma Hendrickson as custodians for the city hall and coliseum. Seconded by Robert Aurand.

Commissioner Aurand moved that the Council accept the offer of Long's Realty in the amount of \$100.00 for that part of land part of Lot 2 northeast fractional one quarter Section 4, 7.23 North, Range 10 East as outlined on the proposal of May 27, 1991. Seconded by Gerald Medlar.

Rita Remrey read a prepared statement to the Council in regard to the alley between Ninth and Tenth Street, next to Countryside Village apartments. The Remreys would like the alley closed and the apartment owners want it left opened so they can build additional parking for the facility and use the alley to get to the proposed parking lot. The Remreys do not want the alley opened up and expressed what they feel are disadvantages if the alley has more use.

Attorney Smith submitted a letter to the Council in regard to a demolition lien against the Sigler property in East Oregon. Due as of May 24 to the City on this lien is \$2,081.43. Scott Hollenbeck, who has purchased the back taxes on this property is offering the City \$1,500.00 to satisfy the lien. If the City does not accept this offer, he will go back and ask the Judge to void the tax sale as the County sold the property as "improved real estate" when it should have been sold as "unimproved".

Commissioner Svoboda moved to accept the offer of \$1,500.00. Seconded by John Priller.

Roll Call: Ayes: Priller, Svoboda. Nays: Aurand, Medlar, Barnes. Motion denied.

Mayor Barnes inquired about the Kopy Kat building. He asked if the City couldn't do something about it. Attorney Smith advised that the City could send them notice to demolish it and if they don't, the City can do it and place a lien against the property. Attorney Smith will write a letter to them and advise them to demolish it or bring the building up to code and give them a certain length of time.

Commissioner Medlar advised he contacted Larry Moring and he got a verbal agreement from him that he would reduce the \$389.50 charge per pick up on lawn waste by \$120.00 per pick up if the City picks up the lawn waste curbside. Moring will bring the dumpster to the street garage and store it and the street department will pick up the lawn waste. People still have to have the Moring bags. The Council agreed to try it. A notice will be published for the June 10 and 24th pick up. The lawn waste has to be at the curb by 7:00 A.M. on pick up day.

Commissioner Svoboda advised the reservoir needs painting and he got a proposal for \$37,000.00 and he feels this has to go for bids.

Sis Braden inquired about getting a catch basin at Tenth & Adams. Mike Bowers advised one will be put in this summer.
