The Council agreed for the street department to proceed with the project.

Nancy Arbogast of 107 North Seventh Street had a complaint about water running onto her property from the street. Mike Bowers and Commissioner Suneson will look into the problem.

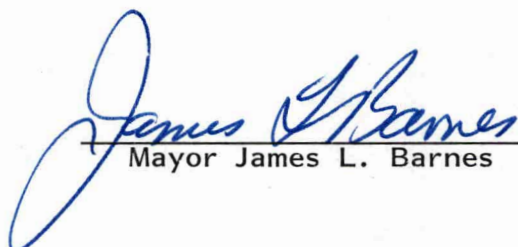
