A petition was presented to the Council by property owners to vacate the alley between Eighth & Ninth Streets in the block between Jefferson and Madison Streets. The Council suggested to the owners to contact the telephone company for an easement for their utility that is on the alleyway and to return to the Council.

Commissioner Lauer advised he had a request from residents in the Koontz Subdivision to install stop signs on Thirteenth Street, Fourteenth Street, Amber Drive and also on Fifth Street at Clay. An ordinance will be prepared for the next meeting.

Requests

Richard Whitney advised that past Commissioner Ludwig had made an agreement with the Ogle County Board to participate in the cost of a sidewalk to the street in the amount of \$1,185.00 on South Fifth Street north of the courthouse annex building. The County is taking out the parking right up to the building, putting in a terrace, curbing and sidewalk and will have parking on the street. Commissioner Lauer agreed to honor the agreement.

Richard Whitney also requested the County be allowed to extend the sidewalk on the west side of the courthouse out to the street and asked for the City financial participation. Commissioner Lauer denied the City's financial participation but asked that the plans be submitted to him on the extension.

Several residents addressed the Council objecting to the construction of the St. Mary's Living Center on South Fifth Street. As that property is properly zoned for that type of facility, there is nothing the City can do about it.

Don Shull requested the Council do something about the unhealthy condition of a residence in the 1000 block of South Fifth Street. He advised the property was run down and there were rats around the property. Commissioner Collins will look into it.

Engineer's Report:

Reports

1. Advised there would be a meeting with Municipal Maintenance representatives next week on the East Oregon Street Maintenance Project.

2. Advised that the Public Hearing notice would be in the newspaper next week for the hearing to be held June 22, 1987 on the Street Lighting Grant.

Chief Miller's Report:

1. Advised he would like to have an ordinance allowing penalties for riding bicycles on the sidewalk in the down town area. After discussion, the Council agreed on the following:

First Offense: A bicycle could be confiscated and the child could come with their parents to redeem the bicycle anytime.

Second Offense: Bicycle held 48 hours and then could be redeemed by the child with his parents.

Third Offense: Bicycle could be held seven days and then redeemed by the child with his parents.

Chief Miller will map out the area in which this would apply.

2. Gave the May Police Activity report.

Commissioner Lauer:

Commissioner Lauer advised that he would like to have the sidewalk ordinance changed to have four inch for residential sidewalks instead of five inch. The Council agreed.

8:30 P.M.- Commissioner Logan moved to adjourn to Executive Session to discuss matters which relate solely to the exercise by the Mayor and the Commissioners of their executive or administrative responsibilities.

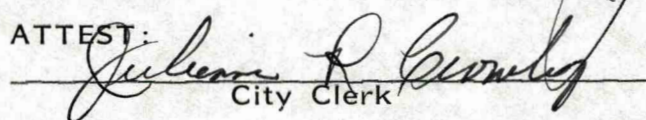
There being no further business, Commissioner Crenshaw moved that the meeting be adjourned.

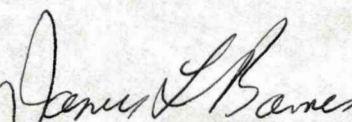
