Police Officer Commissioner Medlar advised he received a letter from Moring Disposal outlining the lawn waste cost reduction of \$120.00 per billing, leaving the cost at \$269.50 per pick up. Moring will sell the City the stickers they have on hand at cost, which is unknown at this time. The City will have to elect to either buy bags, put the stickers on, re-package them and sell them or just go ahead and sell the stickers and let the people buy the bags wherever they want to and buy the stickers from the City. Medlar will contact Moring to see how many bags and stickers are involved and report back to the Council.

Commissioner Svoboda requested permission from the Council to have Willett, Hoffman Engineers inspect the reservoir inside and out and draw up specifications to have whatever work is necessary. The Council approved.

Chief Miller asked that the Council advertise for bids to sell an old squad car. A motion will be ready for the next meeting.

Chief Miller asked that "No Trespassing" signs be placed on all city property.

Commissioner Priller advised that he had been in contact with an individual on possibly getting some federal or state funding for the tree program. It is a 60-40 split where the City would be able to count their percentage by either donated time or services. He would like to pursue this. The Council advised him to try for the maximum.

Attorney Smith gave an update on the Kopy Kat. The title search is complete and the notices will be sent within the next few days.

Mayor Barnes advised that there will be a work day at Sandsucker Recreational Area on June 15th. The committee would like to replace the cable that has been taken from there. Aurand advised he would like to see a road and lights put up at the park. The Council agreed to allow the committee to put the cable back up if it is a temporary solution. They would eventually like to have a road and lights in the area.

Mayor Barnes advised the Council that Commissioner Medlar and he went to Rockford and met with McClure Engineers. They asked for an itemized list of the additional charges and the engineers advised they would get it to the Council by the next meeting. Then if the Council and the engineers do not agree, Barnes asked them to come to the following council meeting which they agreed and they would like for it to be in executive session. McClure engineers assured the Mayor and Commissioner Medlar that they ceased all work upon receipt of the letter dated May 16, 1991 from Attorney Smith in regard to termination of the engineering agreement. The amount invoicing in question is \$52,730.00.

Mayor Barnes moved to go into Executive Session to discuss personnel and acquisition of property.
