Donna Mann had the yearly request from Autumn on Parade. This year the festival is allowing out of county vendors to participate. The vendors will pay double the amount of the Ogle County residents. They are also requesting an additional Street be closed during the weekend of the festival. Franklin Street between 4th & 5th. The businesses in that area will be contacted before that will be approved.

Bob Zittle lives at 209 Hastings Avenue and has a water drainage problem. The Street by his house is not a straight road this was that way when the city annexed the East Side into the city limits. He would like the City to seal coat or build up the road so the rock and gravel don't end up in his yard after a heavy rain. The consensus of the Council was to try and fix his problem at a reasonable cost, but if it doesn't work Bob will have to pay for any other cost occurred. Tom Stone and Mike Bowers will be looking into this matter.

Amy Trimble reminded everyone that the City Picnic is June 20th at Oregon Park West. Also Ron Colson has set up a meeting June 21st at 7:00 P.M. at the Oregon Park District regarding land use planning this will be hosted by the Oregon Plan Commission. Invitations were sent to the surrounding City Councils and Plan Commissions.

The consesus of the council was to go ahead with the lease program for five years from the state to purchase a street sweeper and truck.

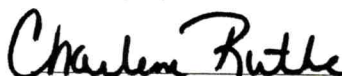
Commissioner Jim Lauer moved to adjourn the meeting, Seconded by Commissioner Amy Trimble.
