Commissioner Svoboda moved to award the contract for the Disposal Plant Grit Channel Replacement and New Sludge Bed to Strong-Bilt Structures, Dixon, Illinois for their low bid of \$122,578.00 for the Grit Channel and \$36,127.00 for the Sludge Bed. Seconded by Robert Aurand.
