Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved that the minutes of the June 8, 1981 meeting be approved as recorded. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Aurand moved that the Annual Financial Statement submitted by Julienne Crowley, City Treasurer, for the fiscal year ending April 30, 1981 be approved and he further moved that said report be published once in the Republican Reporter newspaper in accordance with Illinois Revised Statutes, Chapter 24, Section 3-10-5.1. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Aurand moved that the City's Appropriation Ordinance #851 making appropriations for the fiscal year May 1, 1981 through April 30, 1982 be introduced and filed for public inspection this date. He further moved that a public notice notifying the General Public that said ordinance is available for public inspection and a notice stating that a public hearing thereon will be held July 13, 1981 at 7:15 p.m. The clerk was thereby directed to publish the above notice in the Republican Reporter newspaper on June 25, 1981. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Mayor Barnes moved that Resolution #406 entitled "A Resolution Adopting Illinois Department of Labor Conciliation and Mediation Service Prevailing Rates for Construction Trades" be passed. He further moved that a public notice be published in the Republican Reporter newspaper on Thursday, June 25, 1981 advising the general public that copies of said rate determinations are on file at the City Clerk's office. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Barnes. Nays: Collins, Ludwig.

Mayor Barnes moved that Friday, July 3rd be declared the official July 4th holiday and that the city clerk's office, street, water-sewer, disposal plant and park departments' offices be closed. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Mayor Barnes moved that Robert Adamson be re-appointed as a member of the City of Oregon Coliseum Board, term effective July 1, 1981 through June 30, 1984. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

After a discussion between the council and Edward Van-Weelden, representative of Rock Valley Disposal, Commissioner Svoboda moved that Rock Valley Disposal be given a 12% increase for one year beginning July 1, 1981 and ending June 30, 1982. Seconded by James Ludwig. This brings the residential rate from \$5.00 per month to \$5.60 per month for trash pick up.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Residents from the 700 block of South Sixth Street addressed the council with a request to do something about the flooding in their area. The council advised them they would contact the Illinois Department of Transportation to set up a meeting with them, the city engineer and the council to see if a solution could be worked out.

Pete Alfano, owner of Alfano's Restaurant at Fourth and Gale Streets, addressed the council with a request for a beer and wine license. The council advised Alfano that his location is not zoned for a liquor license and there would have to be a public hearing on zoning if he wished to apply for a license.

After a discussion on the new well and water mains, Commissioner Collins moved to place an invitation for bids for Well #4 in the newspaper for the weeks of June 22nd and June 29th to be opened and read aloud on July 9th, 1981 at 1:00 P.M. at the City Hall in Oregon. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

The council agreed that residents should not park on the city terraces and across the sidewalks and instructed the clerk to have a news release put in the Republican Reporter newspaper advising citizens of this.

Attorney Smith advised the council that he and Commissioner Collins had gone over the Facilities Plan report of Fehr-Graham and had deleted some sections, retyped it and sent it back to Fehr-Graham for their approval. As soon as he receives a reply from them, he will advise the council.

The council discussed the open cistern on the Schrader property at 308 South Third Street and agreed to have Dennis McMullen contact Mike Williams of the County Health Department to see what could be done about it.

Commissioner Ludwig advised the council he had approved a curb cut on North Third Street at the new parking lot of the Catholic Church.

There being no further business, Commissioner Ludwig moved the meeting be adjourned. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.
