They would like to hold this July 10, 1987 from 2 P.M. until 11:00 P.M. It would be for ages eighth grade through seniors in high school. The Council granted permission.

Commissioner Logan advised the Council of old blacktop at Mix Park that was used for a tennis court at one time. He would like to have it removed by the street department when they have time to do it. Council agreed.

Mayor Barnes advised that the swim pool opened Sunday, June 21, 1987.

Mayor Barnes advised that the Burlington Northern Railroad had received permission to tear down the depot if they wished. He wanted the Council's opinion on whether to pursue trying to get the depot for a historical museum. The Council agreed for Mayor Barnes to contact the railroad representative and for him and Commissioner Crenshaw to try to meet with him to see what could be worked out.

Carol Daniels requested Commissioner Lauer to review the deteriorated condition of the sidewalk at 409 South Fifth Street and see if the City could replace it. Lauer agreed to check it.
