Ken Giese, Chairman of the Coliseum Board, advised the Council that the Board would like to proceed with the heating project as submitted by Miner Consultants in the amount of approximately \$34,000.00. He advised that he had talked to Commissioner Logan in regard to the financing of the project.

Reports

The Clerk advised the Council that there has been donations toward Sandsucker Recreational Area. Autumn on Parade donated \$1,500.00; Oregon's Women's Club, \$200.00; Robert Pickel, \$9.50 for the pictures that were developed.

Commissioner Collins would like to have a notice published in regard to the placement of garbage, when it can be placed on the curb, etc.

Commissioner Lauer advised he would like to have Section 9-42, maintenance of trees in the terrace, published so residents will know what is expected of them and from the City.

Commissioner Lauer advised that he is concerned with the vehicles parked along the streets for sale, etc. He feels some are traffic hazards and he will have some suggestions at the next meeting to eliminate this.

Mayor Barnes stated that he had requested some records from Commissioner Crenshaw on sludge removal and has not received them to date. Commissioner Crenshaw advised Mayor Barnes that he was welcome to come to the plant and to look at them. Mayor Barnes advised that he was going to respond to the letter even though Commissioner Crenshaw already has responded to the EPA.

Chief Miller advised that Gary Robinson is still leaving cars outside of the building. His department will continue to take pictures and submit them to Attorney Smith for court action.

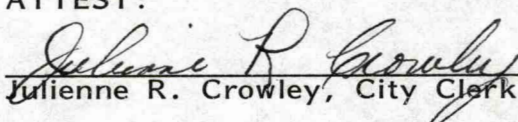

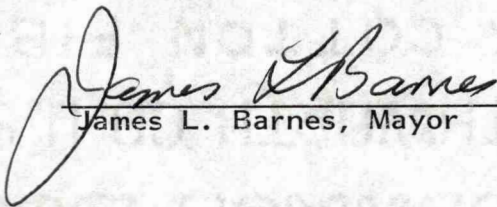
