The Clerk is directed to publish the above notice in the Republican Reporter newspaper on July 1, 1982. Seconded by Norman Collins.

Commissioner Aurand moved that a notice be published in the Republican Reporter newspaper on July 1, 1982 advising the public that a hearing will be held on Monday, July 12, 1982 at 7:20 P.M., City Hall Building, in compliance with Public Act 82-102; Truth-in-Taxation Act. This public hearing to be held concerning the proposed tax levy increase. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Svoboda moved that Ordinance #867, an Ordinance Supplementing Title 4, Chapter 2, entitled "Garbage Removal" be passed. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Aurand moved that Ordinance #868, an Ordinance Amending Title 1, Chapter 14, Section 1, entitled "Depositories Designated" be passed. Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Aurand moved that Ordinance #869, an Ordinance Amending Title 1, Chapters 6 and 10, be introduced and filed for public inspection. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

June 28, 1982 Meeting Continued

Richard Lamm and Robert Rider, representatives of Lindgren, Callahan, Van Osdol and Weaver, auditors for the city, addressed the council to introduce themselves and explain the audit procedure.

The Council discussed the open house for the new well. They agreed to have it on July 11, 1982, Sunday, from 2-4 P.M., at the well site. Refreshments will be served and four prizes will be awarded. The prizes will be from a drawing of those registered at the open house and will consist of two residents south of Washington Street and two residents north of Washington Street to receive two months water and sewer service at no charge. A rain date was set for July 25th.

Attorney Smith advised that there were two 55 gallon drums up at the dump which were not opened. Street Supt. Bacon is to be advised to see what is in the containers.

Commissioner Collins advised the Council he had a request from Lester Sanderson to cut down a mulberry tree which is on Well #1 property. Sanderson will have it taken down if the council approves his request. The council agreed and instructed the Clerk to advise Mr. Sanderson. Also that a certificate of insurance would not be required but that the city will not assume any liability in the case of any damage.

Mayor Barnes advised that Dr. Beckley has requested to hire three instead of four school crossing guards. The council agreed and instructed the clerk to advise Dr. Beckley.

There being no further business, Commissioner Aurand moved that the meeting be adjourned. Seconded by Norman Collins.
