Commissioner Tom Miller commend Commissioner Ken Williams on the zero base budget.

Commissioner Ken Williams announced that Oregon Trail Days is July 20th to July 22nd. The proceeds are to help with the renovation costs for the Chief Blackhawk Statue.

Commissioner Ken Williams brought up the costs of the potential improvements that were outlined in the Capital Improvement Plan; not all these projects will be accomplished but represents the infrastructure needs within the city. The City currently doesn't have funds to pay for these projects. A means of raising revenue for capital improvements is through a 1% sales tax increase; which would bring about \$240,000.00 per year. This extra tax revenue would be paid by non-residents so the full costs of these projects will not fall on city taxpayers alone. He would like to propose a Resolution to the City Council to pass at the next Council meeting to get this on the November ballot for the residents to vote on.
