Commissioner Logan responded to a letter received from Nancy Miller, Chairman from the Autumn on Parade Entertainment Committee, in regard to a complaint about the coliseum scheduling. Logan advised that the letter was a misstatement of facts. Miller was not in attendance at the meeting.

Commissioner Lauer advised that Ed Harazin, Movie Time, wants to install a soft serve ice cream trailer on his property. His property is zoned commercial and it is legal to put the machine on it.

Jack Basler requested permission from the Council to submit a bid for the city petroleum products needs. He would need usage figures to submit a bid.

Basler requested on behalf of the Ogle County Fair Board that the City consider granting an exemption from the sewer rate in regard to the water leaks and gallon usage at the fairgrounds. He advised that the water lines are old and they have had many breaks.

Mayor Barnes advised he had a call from Dan Pratt, TCI Growth, asking if the Council would be voting on the cablevision franchise. He advised Pratt had sent a revised contract and there were many changes which need to be reviewed.

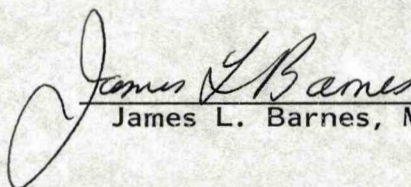
Commissioner Crenshaw questioned Chief Miller's suspension of an officer for three days. Chief Miller advised he would be glad to explain the reasoning to her.

Seconded by Norman Collins.

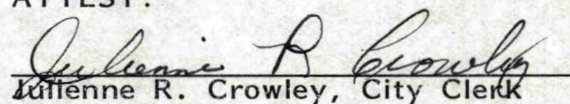
