Commissioner Priller showed the Council the plans on the parking at the Oregon Park District.

Mayor Barnes advised that he met with representatives of the Oregon Park District and School Board. He advised that the estimated cost for the Jefferson Street extension was \$140,000.00 and he advised the other two entities that the City would pay for half of it if accepted. The other representatives were going to take this information back to their Boards.
