Engineer's Report

1. Franklin Street project is started.

2. Mix Street Sanitary Sewer - Dave Martin agreed to pay \$4,500 toward it if it is put in. Attorney Smith is to get an agreement written up for Martin to sign. McMullen is to send Smith a description for the agreement.

3. Franklin Street - the last block between Fifth & Sixth Streets - Council agreed to go ahead with the one block. The cost - \$33,000 - \$34,000. Comply with state regulations of no parking. Engineer is to get a letter from Lawrence & Sons verifying this agreement.

4. Capital Improvements - McMullen to get plans, specs for next meeting on looping Sixth to Eighth Street which is the priority at this time.

Commissioner Ludwig advised that he is working with Howard Fox to get a tree inventory on city trees and it would be presented at the next meeting.

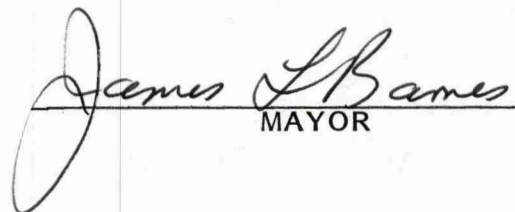
Tree Inventory

Seconded by James Ludwig.

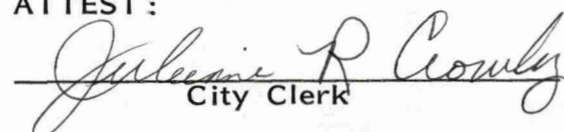
