Commissioner Bob Rees announced that the coliseum roof is leaking again. He is going to contact someone to see how much damage there might be and to see what needs to be repaired. Also a safety gate has been put in by the wading pool. The state inspector mandated that a gate be put in within five days of his inspection.
