Moe Kielsmeier had some concerns with the Kishwaukee College agreement as far as bring more industry in the area and with trying to keep the retail businesses that the city already has in the downtown area. The Mayor stressed that the city would do everything possible to keep the industry and businesses that are already in the city. He also feels that we need to have a public meeting regarding the storm sewer project. The city has already had one but could possibly have another one in the future.

Commissioner Jim Lauer spoke with IDOT to try and work the Washington Street project in with the storm sewer so that the road would not have to be torn up twice.

The City Clerk updated the Council with the area city residency requirement for employees. Six different cities were checked with varying with so many miles or so many minutes from the city limits and two required living in the city limits.

Commissioner Tom Stone moved to change the employee residency requirement from living in the city limits to the boundaries of the school district, Seconded by Commissioner Jim Lauer.

Employee residency Chief Miller gave the Council members a memo with concerns about the kids and littering in front of the Library. He suggested putting up a sign indicating: NO STOPPING, STANDING OR PARKING BETWEEN 9PM AND 4AM. Hoping that this will prevent vehicles from parking and stopping to visit with the ones standing along the street. The police department is attempting to arrive at a solution to solve this problem. The City Clerk will contact other cities to see if they have a littering ordinance to use as a reference.

Commissioner Amy Trimble received a letter from a citizen regarding burning in the city limits. She has asked the City Clerk to check with other surrounding cities to see if they have an ordinance that we could use as a reference. Amy also met with Jim Grove from the Park District regarding property by Sandsucker Park. The Park Dist. would like to trade property by the old Cain Millwork building if they purchase it from the Railroad for the property by Sandsucker Park. The property is about 200 feet. They would like to be able to have a boat ramp at the park. Commissioner Lauer voiced a concern that if the water and sewer plant would need to expand in the future they would need the land that the park district would like to have for the boat ramp. Amy will check with the City Clerk Friday to see if any of the other Commissioners have any other concerns or commits before she meets with Jim Grove.

Commissioner Tom Stone announced that the committee has came to a consensus that the parking meters will be removed. They are not sure when this will take place. A plan is in the works as far as how much the fine will be and they how they will patrol the area.

The Mayor asked Pam from Kishwaukee College how they will start the process on the agreement that was passed earlier in the meeting. She would like to meet individually with each council member, Ron Colson, Donna Mann, and Brian Marinelli for there impute.
