The Council of the City of Oregon met in regular session Monday, July 25, 1983 at 7:00 P.M., City Hall building.

Present: James Barnes, Mayor and Commissioners Norman Collins, Elma Braden, James Ludwig and Frank Svoboda. Absent: None.

Also present: City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Svoboda moved that the minutes of the meeting held July 11, 1983 be approved. Seconded by Elma Braden.

Commissioner Braden moved that the minutes of the executive session held July 11, 1983 be approved. Seconded by James Ludwig.

Mayor Barnes advised that he has an application from Della Long to transfer Electronic Playground mechanical amusement device license from Mark Bethard to her. She will resume operation of the facility on August 1, 1983. The council agreed to the transfer.

Commissioner Collins moved that the audit report filed by Lindgren, Callihan, Weaver and Van Osdol, Certified Public Accountants covering the City's financial transactions for the fiscal year beginning May 1, 1982 and ending April 30, 1983 be accepted. He further moved that the Mayor and City Clerk be authorized to sign said report and that the Clerk be instructed to forward one copy of the financial statement and one copy of the supplemental report to the State Comptroller and one copy of the report to the Revenue Sharing office. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Commissioner Ludwig moved that Resolution #431 requesting the closing of State Route #2 and #64 for the purpose of using the highways during Autumn on Parade be passed. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Mayor Barnes moved to hold a Public Hearing on August 8, 1983 at 7:30 P.M. in regard to applying for an Urban Development Action Grant. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Jim Kaye, editor of the Republican Reporter newspaper, introduced Dave Fox, who will be replacing him at the paper.

Kim Krahenbuhl, representing the Citizens Advisory Committee, appointed by the Oregon Park District, gave a presentation on the committee's recommendation for the park district swim pool facility. He advised there will be an open meeting held Tuesday, August 2, 1983 at 7:00 P.M. at the Nash School for citizen participation on this project.

Dennis McMullen gave a report on various city projects.

At 8:15 P.M. Commissioner Collins moved to adjourn to executive session to discuss information regarding employees. Seconded by Elma Braden.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.
